**Mayor** – Mayor Gros reported on the fair last week. Waiting for one final food bill. Will be able to inform every one of the final profit of the fair. He commended the police officers for the great job they did to make sure the fair was safe. He recognized Fordoche Police Officer Brandon Pridemore for leading the group.

**Town Manager** – The state combined both state appropriations, (Water tower, Water Lines) into one account. This is for easier tracking and management of the projects. This week, we were informed by the Delta Regional Authority that the town was awarded a grant in the total amount of \$396,890.00 for the water tower construction. This will result in the water tower construction being completely funded by this grant and state funds with a total cost of \$2,171,000.00.

**Park/Drainage Commissioner – Ms. Robillard** – Reported that the park playground is complete with its upgrade. She will purchase new swing components this month.

**Beautification Commissioner – Ms. LaCombe** – Reported on efforts for town welcoming signs updating. She and Ms. Robillard discussed having park benches around the pond being sponsored by families. Ms. Lacombe will have an update next meeting.

**Grass Commissioner – Mr. Lacombe** – He is working on getting the tractor with the boom mower repaired. It will have to be picked up by John Deer because of the hydraulic pump is out.

Motion carried unanimously.


