**ORDINANCE SETTING THE SALARY OF THE CHIEF OF POLICE**

**BE IT ORDAINED** by the Fordoche Town Council in regular session convened that the Code of Ordinances of the Town of Fordoche is hereby amended and reenacted to read as follows:

SECTION 1: The Town Council of Fordoche hereby set the current salary of the Police Chief at \$999.00 per month, effective December 10, 2024.

SECTION 2: The salary-increase and applicable benefits for the Police Chief are to be included in the Budget of Anticipated Revenues and Expenditures for 2025.

**AN ORDINANCE ENACTING CHAPTER 31 OF THE  
CODE OF ORDINANCES PROVIDING FOR THE REGULATION  
OF THE TOWN OF FORDOCHE, LOUISIANA OWNED  
EQUIPMENT AND VEHICLES AND OTHERWISE  
PROVIDING WITH RESPECT THERETO**

**BE IT ORDAINED** by the Town Council of the Town of Fordoche, Louisiana, in regular session convened, that Chapter 31 of the Code of Ordinances of the Town of Fordoche, Louisiana is hereby enacted to read as follows:

**WHEREAS**, the town council for the Town of Fordoche, Louisiana desires that a policy be established regarding and regulating the use of Town of Fordoche, Louisiana owned equipment and vehicles

**WHEREAS**, the Town of Fordoche, Louisiana provides equipment and vehicles to its employees, agents, officials and/or officers as well as staff, contractors and volunteers who may use town equipment and vehicles

**NOW, THEREFORE, BE IT ORDAINED** as follows:

**Sec 31 – 1 – Care and Maintenance**

That when using town owned property, equipment and/or vehicles employees, agents and/or officials are required to exercise care, perform required maintenance, and follow all operating instructions, safety standards, and guidelines

**Sec. 31 – 2 – Report of Damage, etc.**

Employees, agents, officials and/or officers must promptly notify their supervisor if any equipment, machines, tools, or vehicles appear to be damaged, defective, or in need of repair. Prompt reporting of damages, defects, and the need for repairs could prevent deterioration of equipment and possible injury to employees or others. Employees, agents, officials and/or officers must also promptly notify their supervisor or the mayor if any equipment is lost, not returned to the place it is normally stored or parked, or otherwise goes missing

**Sec. 31 – 3 – Prohibition from Using Town Equipment**

Employees, agents, officials and/or officers are strictly prohibited from using Town of Fordoche, Louisiana equipment and/or vehicles for any personal, private, or political purposes

**Sec. 31 – 4 – Prohibition Relative to Town Vehicle Usage**

Personal use of Town of Fordoche, Louisiana vehicles, or use of such vehicles for any other reason than performance of duties or transport to and from Town of Fordoche, Louisiana work assignments, is prohibited unless specifically authorized by the mayor. Acceptable use of a town vehicle outside the corporate boundaries of the Town of Fordoche, Louisiana is limited to travel when there is a discernible public interest

**Sec. 31 – 5 – Penalties**

Failure to abide by the rules and regulations promulgated by this ordinance shall be cause for discipline, which can include written reprimands, suspension, demotion, salary reduction or termination and/or other applicable penalties as provided in the Town of Fordoche, Louisiana Code of Ordinances

**AMENDING CHAPTER 12 ARTICLE II DIVISION 2  
SECTION 12-40 OF THE CODE OF ORDINANCES PERTAINING  
TO LITTERING AND MATTERS INCIDENTAL THERETO**

BE IT ORDAINED by the Town Council of the Town of Fordoche, Louisiana, in regular session convened, that Section 12-40 of the Code of Ordinances of the Town of Fordoche, Louisiana is hereby amended and reenacted to read as follows:

**Sec. 12-40 – Unlawful to litter garbage, trash, etc., within the town.**

It shall be unlawful for any person to scatter, throw, deposit, drop, allow, or to permit or allow to be scattered, spilled, thrown, deposited or dropped, any garbage, trash and other waste material, dead animals or fowl, industrial waste or refuse or abandoned major appliances, lumber, machinery, metal, tin, tires, rims, boats, motors, auto parts, barrels, yard waste, or other discarded or abandoned items, offensive to smell or injurious to health in any private yard, lot, room or building, or on any sidewalk, street, alley, wharf, levee, public parkway, public right-of-way or any other public place, or in any gutter or drain within the town other than in the usual garbage container. The presence of such items is hereby declared to be a public nuisance.

**Section 12-41 Definitions**

As used in this Chapter, the following term(s) shall have the respective meanings ascribed to them:

- (1) “Inspector” means a duly authorized agent of the town.

**Section 12-42 Notice to remove**

In order to more effectively carry out the intent of Section 12-40 the clerk, upon instructions by the mayor, shall provide written notice to remove the nuisance to the property owner, as determined from the latest assessment rolls, failing to comply with the requirement of this Chapter, requiring the property owner to comply with this Chapter within ten (10) days of receipt thereof. The notice shall be sent by registered or certified mail, return receipt requested or served by a law enforcement officer.

**Section 12-43 Judicial review**

Any person receiving notice that he is in violation of the requirements of this Chapter may, request within the ten (10) day period after receipt of notice, either in person or in writing and without the requirement of bond, that a date and time be set when he may appear before the mayor’s court to determine whether he is in violation of this Chapter and whether a public nuisance as defined in Section 12-40 exists.

**Section 12-44 Failure to remove**

If there has been no compliance with the requirements of this Chapter within ten (10) days of receipt of notice and there has been no timely request for a judicial hearing, the junk/litter listed in Section 12-40 shall be removed and disposed of by the town as the council and the mayor may designate. The clerk shall then cause a statement, giving a description of the property and cost incurred in removing the material, to be filed and recorded in the mortgage records of the parish; and when so filed and recorded, the statement shall constitute a lien upon the property from the date of recordation.

**Section 12-45 Right of entry of inspectors**

Upon presentation of credentials, an inspector may enter, at reasonable times, any premise in the town to inspect such for compliance with this Chapter.

**Section 12-46 Penalties**

Any person who fails or neglects to comply with this Chapter within ten (10) days of a judgment of the mayor’s court determining that he is in violation thereof, upon conviction, shall be sentenced to pay a fine of not more than five hundred (\$500) dollars, imprisonment not to exceed sixty (60) days, or both. Each day such violation occurs shall be considered a separate offense.


