Reports

Town Manager– Justin Cox had a meeting with Delta Regional Authority and was given a templet to do quarterly reports. Construction starts in August. We received \$75,000 in funding for a tractor and \$25,000 funding to use accordingly as needed in the general fund. Water inspection was done last month, Charles Bates resolved all issues and is performing daily testing. Property condemnation letters were served. 5 culverts were replaced and various ditches were cleaned.

Police – Chief Derrick Poirrier reported on calls for service for June 2025, traffic enforcement has resulted in 5 citations issued in June 2025. Computers are now updated with technology and systems updates. Fleets have been maintained and serviced.

Drainage Commissioner – Ms. Robillard stated she needs a list of culverts to be blown out. Mr. LaCombe stated they are working to keep culverts clean, as parishioners are throwing limbs in ditches which blocks drainage.

Beautification Commissioner – Ms. LaCombe needs flags to be ordered. We will get plants and soil to put in the pots in front of town hall.

Grass Commissioner – Mr. Lacombe stated the roadside from the road is cut. The whole town has been sprayed where needed and uncut.

Parks/Rec - A water fountain and more playground equipment will be added to the park.

Motion carried unanimously.


Citizen Bambi Martin – Mobile home ordinance variation request.
